- 4. 2019 Development Plan, Budget Statement and Treasurer's Report
 - (1) Progress on the delivery of the 2019 Plan was noted.
 - (2) The December 2019 Budget v Actual Statement recording income, expenditure and Reserves, plus a provisional year end forecast was reviewed and agreed. NC will use as basis for updating for her year-end preparations.
 - (3) NC outlined her year-end timetable for preparation and submission of the 2019 Financial Statements to CIPFA (required by 24 January 2020) and for audit. She will liaise with Alina G-C to finalise the London Division bank account transfer.

Council noted that this version was submitted to CIPFA to support our 2020 subvention bid

of £18k for 2020 which had now been approved. Council was invited to suggest any modifications to this version by 15 January 2020. It is proposed that a formal approval of the 2020 Development Plan, with an accompanying budget, should be given at our January Council meeting.
